CIRCULAR

Sub: AEPC's participation in INTERMODA, MEXICO 18TH - 21ST JANUARY, 2011

ABOUT INTERMODA:

INTERMODA is the biggest and most important fashion exhibition show in Mexico and Latin America and is aimed at the professionals of the fashion and textile industries. It was established in the city of Guadalajara, Mexico for last 25 years.

INTERMODA has consolidated its presence in the market, creating space in which major brands of fashion and textile industries are present. Held biannually for a period of four days, **INTERMODA** is the meeting place for intense activities of more than 650 exhibitors. The event draws buyers from all over Mexico and international markets.

INTERMODA has gained transnational focus due to its success and have established new business opportunities with countries like Argentina, Colombia, Peru, Chile, USA and India among others. The fair showcase Menswear, Women wear, Children's wear, Textiles items and Accessories for the Spring - Summer collection for the year 2011.

OBJECTIVE:

INTERMODA's main objective is to maintain a long term stable business relationship with all sectors of the fashion in Mexico, especially by increasing the quality and quantity of attendees and buyers at the event.

RMG Figures:

In LAC region, Mexico is an important market having a potential of USD 1.9 Billion imports of readymade garments. The exports of garments from India to Mexico crossed the mark of USD 111 Million in the year 2009, which accounted for more than 5.70% of Mexico's overall ready made garments import from the world.

Most significant items of import from India were Men's or Boys' Shirts, Knitted or Crocheted (6105) and T-Shirts, Singlets, Tank Tops Etc, Knit or Crocheted (6109) in case of knit items; and Women's or Girls' Blouses, Shirts Etc Not Knit Etc (6206) and Women's or Girls' Suits, Ensemble Etc, Not Knit Etc (6204) in case of woven items.

VENUE:

The venue would be Guadalajara Exhibition complex, Guadalajara, Mexico.

DATE:

18-21 January 2011 (Tuesday, Wednesday, Thursday and Friday)

PARTICIPATION CHARGES AND LAST DATE:

This is a right opportunity for you to participate in large apparel market of Mexico. The booth package and other details are as follows:

Nett cost per booth	:	Rs. 95,000/-

MDA will be admissible as per the MDA norms.

The application would be considered on First-cum-First Served (FCFS) basis.

BOOTH PACKAGE :

Hardwalls booth, 1 table, 3 chairs, Name Fascia, Hanger Rails 2 Nos: (One mtr. Size), 100 plastic hangers, Carpeted floor, Common waste paper basket, 24 hours a day security, Visitor registration services and control, Company information in Exhibitor's directory.

The application form is attached herewith. You are requested to kindly send the participation fee by way of Demand Draft/Pay Order in favour of "APPAREL EXPORT PROMOTION COUNCIL" as per the above to A.E.P.C., Apparel House, Institutional Area, Sector - 44, Gurgaon - 122 003.

The exporters of Delhi/ Gurgaon can also deposit the payment by way of cheque to APPAREL EXPORT PROMOTION COUNCIL, Gurgaon office. Similarly, exporters at Mumbai, Ludhiana, Jaipur, Tirupur, Chennai, Bangalore and Kolkata can also deposit the cheque at Local AEPC offices. All others may send the Demand Draft/Pay Orders to Gurgaon office. Post dated cheques are not allowed.

GUIDELINES FOR ALLOTMENT OF THE BOOTHS:

1. All participants who have paid the full participation fee in time would be considered for allotment of booths through alphabetical order.
2. The decision of SG/Chairman (EP) would be final in case of any clarification.
3. No change in the booths, once allotted would be entertained under any circumstances.

WAITLIST

In case, applications are over-subscribed beyond 10 nos. participation, a waitlist will be maintained, which would be treated on FCFS basis. Applicants are advised to ensure that they possess necessary visa to enter Mexico. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

CANCELLATION CHARGES

The exporter who has applied for participation in the Fair, the withdrawal will be subject to following:

- A. 25% of participation charges will be forfeited if the exporter withdraws before the participation is confirmed by the Council and other participant on the wait list

confirms their participation. However, the forfeiture will be 35% of participation fees, in case, there is no other participant on the wait list.

- B. 45% of the participation charges will be forfeited if the exporter withdraws after confirmation of participation by the Council and other exporters on wait list confirms their participation. There will be forfeiture of 65% of participation fee if no other exporter is on the wait list.
- C. 100% forfeiture in case of no show of the fair.
- D. Non-grant of relevant visa shall not qualify for any relief.
- E. The application would be considered on First-cum-First Served (FCFS) basis.
