The Firms/ Companies/ Suppliers/contractors are requested to inspect the site of work before quoting their rates in their own interest.

2. SCOPE OF WORK:

- 2. Dismantling of Existing ACs mentioned above along with all related accessories without damaging the existing structure of the premises.
- 3. Agency to supply, install, test and commission the new split/ductable ACs with all related accessories
- 4. The agency would provide the rates for supply and installation as per financial bid mentioned in Annexure –III

- 5. The repair/installation work would be completed under supervision of AEPC Engineer In charge.
- 6. As the work site is an operational office, all necessary steps must be taken not to disrupt the working of the office and does not cause any interruptions during the office hours.
- 7. For dismantling of existing Air Conditioners and installation of new Air Conditioners, the site will be available after office hours, Holidays and at weekends (Saturday & Sunday) only. The agency must ensure that all work undertaken are made good for working of the office for the next day and causing no inconvenience to the office staff/property.

3. Eligibility Criteria for Contractor

- A.i. The Contractor should have the technical competence, financial resources, equipment and other physical facilities, managerial capability, reliability, experience, reputation and the personnel, to perform the works contract.
- A.ii. The Contractor should have handled such type of composite works including supply, install, test, commission of ACs of at least one work of Rs. 25 lacs or more during last three years in any Govt. / Semi Government/ any Government undertaking / Private Sector.
- A.iii. Average Annual Financial turnover from Contract value should not be less than Rs. 50 lakhs per annum during the last three financial years. The bidder is required to submit the copy of Audited Balance Sheet for the last three financial years.
- A.iv. Contractor should not have been blacklisted by any Central /State Government / Public Sector Undertaking.
- A.v. Contractor should not be insolvent, in receivership, bankrupt or being wound up, their affairs are not being administered by the Court or a judicial officer, their business activities have not been suspended and should not be the subject of legal proceedings of any of the foregoing.
- A.vi. Contractor should not have been convicted of any criminal offence related to professional conduct or the making of false statement or misrepresentation as to their qualifications.
- A.vii. Contractor should have in its name PAN (Permanent Account Number) with Income Tax authority in India
- A.viii. The Contractor should have in its name GST Registration number in India
- A.ix. The Contractor should have ESI & EPF Registration with concerned authority

All above eligibility criteria shall be supported by relevant documentary proof.

4. Evaluation Criteria

4.1 First the Technical Bid will be opened and screened. The short listing of bidders will be done based on their past experience, track record, accreditations, strength of manpower, experience and qualification, financial

strength, etc.

4.2 Financial Bid will be opened for only firms shortlisted under 4.1 above.

5. Final Selection of Agency:

The Lowest Financial Bid (L1) will be awarded the contract and the decision of the AEPC shall be final and binding on all.

The Technical bids will be opened at 11.30 AM on 23rd January, 2018 and Financial Bid will be opened at 11.00 am on 25th January, 2018 at Apparel House, Sector-44, Gurgaon.

6. **EARNEST MONEY DEPOSIT**

- a) The Tenderer is required to deposit Rs. 50,000/- (Rupees Fifty Thousand only) as Earnest Money Deposit along with the tender in the form of Demand Draft/Pay Order/ Bankers Cheque of any Nationalized Bank drawn in favour of Apparel Export Promotion Council, payable at Gurgaon. The tender document which is not accompanied with Earnest Money shall be summarily rejected.
- b) Demand Draft for the Earnest money should be enclosed in a separate envelop (No. 1) and be marked "EARNEST MONEY DEPOSIT". Tender documents should be enclosed in separate envelopes and be marked "TENDER DOCUMENTS— Technical bid (No. 2), Financial Bid (No. 3)". All these envelopes be put in one large envelope (No. 4) and should be submitted.
- c) The EMDs of the unsuccessful agencies will be refunded by way of handing over the original Demand Draft / Pay Order / Bankers Cheque duly endorsed by the Competent Authority of the Council without any interest/bank commission collection charges, within 30 (thirty) days from the date of opening of the Financial bid.
- d) The EMD of the successful agency will be retained by the Council as performance **Security Deposit** till the completion of **12 months as the defect liability period** from the date of issuance of actual completion certificate issued by Engineer In charge AEPC.

7. **PERFORMANCE SECURITY DEPOSIT**

a) The amount of Performance Security Deposit would be 5% of the total contract value and the Earnest Money deposited by the successful Tenderer shall

be retained as part of Performance Guarantee. In case, the amount of EMD happens to be less than 5% of the total contract value, the adequate security deposit amount shall be brought by the Agency while accepting the work order.

- b) The said amount of Performance Security Deposit should be interest free and no interest will be paid by AEPC. The performance guarantee would be refunded after the completion of defect liability period.
- 8. Before submitting the quotations, bidder may visit the site of works at First Floor, 15, NBCC Tower, Bhikaji Cama Place, New Delhi for inspection of existing Air Conditioning Units and to ascertain the physical site conditions.
- 9. The site would be available for inspection in the presence of Engineer in Charge, AEPC, between 10.00 a.m. to 4.30 p.m. on 30th & 31st December, 2017 and 6th and 7th January, 2018 only. The interested bidders may contact Engineer in Charge, AEPC on mobile at +91 9868207280 for fixing their prior appointment.
- 10. Defect Liability period shall be 12 (Twelve) months from the date of issuance of actual work completion certificate by Engineer-in-charge, AEPC.
- 11. The tenders shall remain valid for a period of 6 months from the date of opening of tender.
- 12. All the communications will be addressed to Director- Assets, Apparel Export Promotion Council, Apparel House, Sector-44, Gurgaon, Haryana.

- 1. The financial bid shall furnish detail of all taxes as applicable.
- 2. The quotation should be submitted on firm's letter head along with address, telephone number, PAN Number, GST no. etc.
- 3. The approved rates of the firm will be valid **for 6 months** from the date of issuance of Work Order.
- 4. In case of any delay in project / late deliverable by the contractor, no escalation will be entertained in any circumstances and the rate quoted by the contractor at the time of award will be valid up till the completion of the project
- 5. The contractor/agency shall be solely responsible for the dismantling of old equipments, procurement of materials, supply of trained and experienced manpower, transportation, logistics, storage/warehousing, installation, tools & tackles, safety equipments and regulations, testing, commissioning of the works specified in the Scope of Work.
- 6. In case of any extra items which may rise as per the requirement of work, the same may be executed subject to the prior approval of AEPC and the rates for the same shall be considered as per latest DSR (Delhi Schedule Rates) available at that time and no additional charges will be added.
- 7. Unsealed / unsigned Tenders shall not be considered for evaluation. Tenders without EMD shall be summarily rejected. There should be no erasing and/or overwriting. The Tenders with

erasing and/or overwriting shall be summarily rejected.

- 8. The rate should be mentioned clearly in words inclusive of all taxes as applicable in the financial bid mentioned at **Annexure III.** The taxes and other levies, if any, should be indicated separately. In case nothing is mentioned, it will be assumed that taxes/other levies are included in the rates quoted.
- 9. Financial bids should be submitted in the prescribed formats only. The financial bids submitted in any other format will not be accepted.
- 10. The contract can be terminated by this office at any time without assigning any reason, if the work of the contractor is not found satisfactorily. In this connection, the decision of Chairman, AEPC shall be final and binding on the contractor.
 - 11. The contractor has to carry out the defect works noticed by the office (AEPC) at the cost of contractor during the defect liability period of 12 months. If the Contractors do not carry out the rectification work during the Defects Liability Period, the AEPC shall have the right to get such defective work rectified after giving due notice in writing to the Contractors and recover the cost of repairs from the amount so retained as Performance Security Deposit.
- 12. This office (AEPC) has the right to forfeit the Performance Security Deposit in full or in part in the event of failure on the part of contractor to fulfill the terms and conditions of the contractor.
- 13. After expiry of last date, no Tender document will be entertained.
- 14. The awarded work should be completed within 60 days on weekends / holidays only i.e. 8 Saturday & 8 Sunday + holiday, if any from the date of issuance of Work Order / Award Letter. If it is not completed within the time as specify in the work order then the liquidity damage @1% of the value of works, per week, up to maximum of 10 % of contract value will be imposed on the contractor.
- 15. The contractor or his authorized representative could be present at the times of opening of bids, if they so desire.
- 16. The entire workforce deployed by the contractor/agency shall be physically and technically capable of executing their assigned work. Any damages to the property arising out of negligence of the workforce deputed by the contractor/agency shall be the sole responsibility of the contractor/agency to rectify the same at their own cost and on immediate basis. Failure to do so would result in subsequent recovery of the same from the contractor/agency's bills or performance security deposit.
- 17. In case of any incident occurs with the deployed labour of the contractor / agency while

working, will be the sole responsibility of the contractor / agency. This office (AEPC) will not liable for any claiming. Further, no labour below the age of 18 years shall be employed on the work and Labour shall be employed as per minimum wages act as applicable.

- 18. The selected agency should not sublet the work in part or full to another agency.
- 19. The contract shall be terminated in respect of the followings:-
 - (i) If, the service of the agency is not found satisfactory or the agency changes the rate of contract during the contract period.
 - (ii) In case the agency fails to execute the job as per the terms and conditions of the agreement, the balance / total work will be got executed through other agencies at the agency's risk and cost.
 - (iii) The decision of the AEPC will be final and binding on the agency and no request will be entertained in any manner.
- 20. The losses to the AEPC which are directly attributable to the agency shall be deducted from the bills /adjusted from the performance guarantee.

21. Penalty Clause:

- a) For non-performance and on mid-way unilateral withdrawal from the assignment by the agency, the performance security deposit will be forfeited.
- b) The proportionate penalty as decided by the Chairman, AEPC will be imposed and deducted from the final bill.
- c) The EMD shall be forfeited by the AEPC in case:
- i. The bidder withdraws their offer during the period of tender validity.
- ii. After opening of Financial Bids, the bidder fails to honor the contract or refuses to comply with any or all terms and conditions of the tender.
- iii. If the services of the Agency is not found satisfactory as per the terms & conditions of the tender.

22. Terms of Payment

The terms of payment would be as follows:-

- A.ix.a) On the request of the contractor, 50% of the materials cost will be paid subject to the delivery of materials at site and producing of copies of bills/invoice of material by the contractor.
- A.ix.b) The balance payment would be made after completion of the project subject to submission of final Bill/Invoice with all supporting documents including individual warranty cards along with work completion certificate issued by the Engineer-In-Charge, AEPC.
- A.ix.c) The rates which are required to be quoted in per unit rate will be measured at site for actual measurements and payment shall be made in accordance to the Page 10 of 19

actual measurements measured and verified by Engineer-in-Charge, AEPC.

A.ix.d) TDS will be deducted as per the provisions of Income Tax act, as amended from time to time.

23. **Arbitration:**

AEPC has the right to accept or reject any tender in whole or part or reject it entirely without assigning / specifying any reason thereof. In the event of any dispute or difference arising between the AEPC and Contractor out of or relating to or in respect of the contract, the same shall be referred to the arbitration of the sole arbitrator to be appointed by the AEPC in accordance with The Arbitration and Conciliation Act, 1996, as amended. The arbitrator shall give reason for the award which shall be final and binding between the AEPC and Contractor. The venue of such arbitration shall be at Apparel House, Gurgaon, Haryana.

Further, the Courts at Gurgaon, Haryana shall have jurisdiction to try and or entertain any matter of disputes arising out of, and or relating to, or in connection with the contract and shall be governed by Indian Law.
