Notice Inviting e-Quotation

Apparel Export Promotion Council, having its head office at “Apparel House”, Sector-44, Institutional Area, Gurgaon-122003, Haryana invites e-quotations from registered and reputed Insurance Companies having valid license issued by the IRDA for providing insurance policy for Building, inventories, Glasses, sanitary fittings, public liability etc. against fire and allied perils, natural calamity such as earthquake etc including terror attack. General terms and conditions:-

- i. The Insurance Company should be registered, licensed by IRDA for providing policy.
- ii. The Insurance Company should have a paid up capital of at least Rs. 100 crores.
- iii. The Insurance company should submit a list of 5 (five) reputed Government/Public sector enterprises clients where such insurance policy is provided.
- iv. **The Insurance Company should submit a copy of audited accounts for previous 03 financial years i.e 2018-19, 2019-20, 2020-21.**
- v. The Insurance Company should have sufficient number of management staff.
- vi. The Insurance Company shall submit a copy of GST Certificate, Tax compliance certificate, Certificate of Registration/Incorporation and ESI, PF etc.
- vii. AEPC will accept only one quote per Insurance Company. One most competitive offer from empaneled Insurance Company located in New Delhi would be accepted.
- viii. The quotation shall be accompanied with an Earnest Money Deposit (EMD) of Rs.20,000/- **(Rupees twenty thousand only)** in the form of NEFT/electronic transfer from any Scheduled Banks in favour of Apparel Export Promotion Council, payable at Gurgaon along with Bid document. In no case, cheques and /or cash will be accepted. Exemptions of submission of EMD shall be allowed upon attaching of relevant documents along with the exemption clauses laid by any competent regulatory bodies. The Bid received without EMD or exemption documents or incomplete in any respect shall be summarily rejected and no Participant shall have any right to represent. EMD of the successful bidder will be released upon completion of the insurance coverage tenure. EMD of unsuccessful bidders shall be returned upon finalization of insurance agency. No interest shall be paid by the Council on Earnest Money or Security Deposit. In case, EMD is not applicable, relevant notification shall be furnished. - ix. The Insurance Company shall furnish a declaration as per **Annexure-I** along with the duly filled up and signed Bid documents.
- x. **Participant has to submit declaration along with bid stating that they have not been Black-Listed/De-listed by any Indian Institutional Agency/Government Department/ Public Sector Undertaking in the last three years.**
- xi. The Bid should be accompanied by an authorization letter signed by Regional/Divisional officers authorized to submit offers. In case of multiple quotes participated directly by same Insurance Company, AEPC reserves the right to reject any/all quotes.
- xii. **The Council may get valuation of the building done and the insurance value is liable to increase/decrease. IN case of increase in the insurance value, the successful bidder would be required to provide the insurance at the increased value. The Council would pay the addon/topup insurance premium. Similarly, in case of decrease in the insurance**

value, the successful bidder would be required to provide the insurance at the decreased value and the excess premium amount would be returned to the Council.

- xiii. The insurance Company so appointed for the above Bid would ensure submission of insurance certificate, bills and other related documents within 24 hours from the date and time of placement of Insurance Business.
- xiv. The surveyor will be deputed within 24 hours to inspect the site for loss assessment. The insurance claim, if any, would also be settled within 15 days after submission of documents by AEPC to Insurance Company.
- xv. The policy will be for One Year only and the expiry date will be from the date of inception.
- xvi. The Council reserves the right to reject any or all quotations without assigning any reasons thereof.
- xvii. In case of any dispute, decision of Secretary General, AEPC will be binding on all and final.
- xviii. Payment will be made on submission of Insurance Certificate and on receipt of original bill complete in all respect.
- xix. The Participants are advised to visit the premises before submission of Bid document. Inspection of premises can be done on any working days between 10 AM to 4 PM to ascertain and understand the Bid requirement.
- xx. **All criteria and limiting factors detrimental in claim processes shall be specified clearly**

The Bid document complete in all respect duly filled up and signed (all pages) along with required supporting documents should be submitted online to tender@aepcindia.com latest by 11th August, 2022. Quotations submitted in any other format shall be summarily rejected.
