Sub.: Amendment of Importer-Exporter Code (IEC) related provisions under Chapter-1 and Chapter-2 of Foreign Trade Policy, 2015-2020

Dear Members,

This is to inform you that DGFT vide its <u>Notification No. 58/2015-20</u> has amended the IEC related provisions under Chapter-1 and Chapter-2 of Foreign Trade Policy, 2015-2020.

- 2. The amended provisions are explained in paragraph 3 & 4 given below. Specific attention of the members are invited to the changes carried out in Chapter 2 of the FTP in paragraph 4 below. IEC holders has to ensure that details in its IEC is updated electronically every year during April June period. Even if, there are no changes in the IEC details, same also needs to be confirmed on-line. An IEC shall be deactivated, if it is not updated within the prescribed time. Hence all the members are requested to ensure updation of their IEC, as given in this Notification, so that they do not face any problem because of de-activation of IEC.
- 3. Following paragraphs of Foreign Trade Policy, 2015-2020 are amended as below:
