Apparel Export Promotion Council (AEPC) is participating in Saudi Fashion & Tex Expo to be held from 24th to 27th September, 2026, which will take place at Jeddah International Exhibition & Convention Center, Jeddah, Saudi Arabia.

1. About SAUDI FASHION & TEX EXPO - The event is Saudi Arabia's biggest Fashion & Textile Show and is dedicated to the latest innovations, trends and advancements in apparel & fashion, textiles and leather products and this show provides an unparalleled platform to connect with key industry players, potential buyers and global fashion leaders.

4th (edition) Saudi Fashion & Tex Expo- Saudi International Fashion, Textiles & Leather Exhibition will open its doors in Jeddah International Exhibition & Convention Center with the participation of leading garment exhibitors and brands from the most prestigious fashion and textile producers of the region. This platform allows national and international companies of different industry sectors with the support of the **Riyadh Chamber of Commerce**, to show and promote their skills, meet partners and venture into a new and thriving market. The previous event featured 450 exhibitors and attracted 12,420 buyers. This year, approximately 550 exhibitors are being planned to participate.

Saudi Fashion & Tex Expo will feature thousands of latest trends and textile products by gathering fashion specialists and textile buyers from the Gulf and African countries. The fair is the key hub for textile producers who aim to reach wholesalers, retailers, chain stores, boutique owners, agents, distributors, designers, department stores, purchasing offices. Dedicated to innovative and the latest designs Saudi Fashion & Tex Expo is the unique textile platform to expand trader's network and experience the latest technologies and trends.

2. Schedule:

The Saudi Fashion & Tex Expo Fair shall take place at Jeddah, Saudi Arabia on the following dates:-

4. Participation Charges for exhibitors:

THE ABOVE PRICE IS TENTATIVE AND SUBJECT TO THE AVAILABILITY OF MAS GRANT ONLY. IN CASE THE GRANT IS NOT AVAILABLE AS EXPECTED, THE BALANCE AMOUNT WILL BE RECOVERED BY THE COUNCIL FROM THE PARTICIPANTS.

5. Financial Assistance under the Market Access Support (MAS) Schemes under Export Promotion Mission (EPM) of the Central Government Regarding:

5.1 All members who wish to avail financial assistance under the Export Promotion Mission (EPM) are advised to carefully review and promptly fulfil the eligibility requirements prescribed under the Market Access Support (MAS) Schemes of the Central Government. These requirements are outlined in the official guidelines issued by the Government and are available on <https://www.trade.gov.in/pages/Market-access-Support> and is currently available on the link (<https://content.trade.gov.in/EPM-Scheme-Guidelines/Guidelines-for-Support-for-Market-Access-under-the-Export-Promotion-Mission.pdf>). Members are further advised that non-compliance with these requirements may result in rejection of claims.

5.2. These guidelines are subject to revision and will be updated from time to time. Members are advised to remain apprised of the same and take necessary action accordingly in a timely manner. Members are advised to keep themselves updated in this regard by visiting <https://www.trade.gov.in/>

5.3 The Apparel Export Promotion Council has submitted the proposal to the concerned Ministry seeking grants under the **Market Access Scheme (MAS)** of the **Export Promotion Mission (EPM)** for participation in the above-mentioned event. The Ministry's decision on the proposal is currently awaited, and no grant shall be deemed sanctioned or approved unless and until formal written confirmation is received.

5.4 Upon receipt of the MAI/MAS grant from the Ministry, the booth cost will be subsidized and the balance amount will be refunded to the eligible exporters accordingly.

The number of exhibitors eligible to receive financial assistance under the schemes framed under the Export Promotion Mission (EPM) shall be determined by the Government of India through the concerned Ministry (ies). Financial assistance will accordingly be extended only to the number of exhibitors as approved by the Ministry. In the

event that the number of exhibitors approved for financial assistance is fewer than the number of exhibitors who actually participated in the event, assistance from the Government shall be granted strictly on a first-come, first-served basis. Members are therefore advised to submit their applications promptly and in full conformity with these provisions, keeping in view that assistance will be limited to the extent sanctioned.

6. The deadline for submitting the application along with payment is 17th August, 2026.

NOTE:

- a) No cheque payment will be accepted.
- b) Please ensure to share the UTR Details in case of online payment, failing which your participation would not be considered even if payment is already made.

8. Booth Packages: The booth package includes Stand construction, Wall elements, 1 Round Table, 3 Chairs, 2 Led Light 50w, 1 Trash Can, 3 Shelves OR 3 Wall Mounted Hanging Rods, 1 Information Counter, 1 Electric Plug, Fascia Name on each open side.

9. Guidelines for allotment of the booths:

- i. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot by AEPC.
- ii. No change in the booths, once allotted would be entertained under any circumstances.
- iii. The decision of Chairman-EP (AEPC) / Chairman (AEPC) would be final and binding in case of any dispute.
- iv. The participation is on **FIRST-CUM-FIRST SERVED (FCFS)** till all booths are sold and the allotment of stalls shall be done through draw of lot basis.

10. Waitlist:

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess will obtain necessary visa to enter Saudi Arabia. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

11. Cancellation charges: Terms & conditions for withdrawal will be as follows:

- Rs. 25,000/- + GST charges will be forfeited if the exporter withdraws before the Draw of Lot.
- 100% forfeiture after Draw of Lot.
