- iv. **The Insurance Company should submit a copy of audited accounts for previous 03 financial years i.e 2019-20, 2020-21,2021-22.**
- v. The Insurance Company should have sufficient number of management staff.
- vi. The Insurance Company shall submit a copy of GST Certificate, Tax compliance certificate, Certificate of Registration/Incorporation and ESI, PF etc.
- vii. AEPC will accept only one quote per Insurance Company. One most competitive offer from empaneled Insurance Company located in New Delhi would be accepted.
- viii. The quotation shall be accompanied with an Earnest Money Deposit (EMD) of Rs.20,000/- **(Rupees twenty thousand only)** in the form of NEFT/electronic transfer from any Scheduled Banks in favour of Apparel Export Promotion Council, payable at Gurgaon along with Bid document. In no case, cheques and /or cash will be accepted. Exemptions of submission of EMD shall be allowed upon attaching of relevant documents along with the exemption clauses laid by any competent regulatory bodies. The Bid received without EMD or exemption documents or incomplete in any respect shall be summarily rejected and no Participant shall have any right to represent. EMD of the successful bidder will be released upon completion of the insurance coverage tenure. EMD of unsuccessful bidders shall be returned upon finalization of insurance agency. No interest shall be paid by the Council on Earnest Money or Security Deposit. In case, EMD is not applicable, relevant notification shall be furnished. - xi. The Bid should be accompanied by an authorization letter signed by Regional/Divisional officers authorized to submit offers. In case of multiple quotes participated directly by same Insurance Company, AEPC reserves the right to reject any/all quotes.
- xii. The insurance Company so appointed for the above Bid would ensure submission of insurance certificate, bills and other related documents within 24 hours from the date and time of placement of Insurance Business.
- xiii. The surveyor will be deputed within 24 hours to inspect the site for loss assessment. The insurance claim, if any, would also be settled within 15 days after submission of documents by AEPC to Insurance Company.
- xiv. The policy will be for One Year only and the expiry date will be from the date of inception.

- xv. The Council reserves the right to reject any or all quotations without assigning any reasons thereof.
- xvi. In case of any dispute, decision of Secretary General, AEPC will be binding on all and final.
- xvii. Payment will be made on submission of Insurance Certificate and on receipt of original bill complete in all respect.
