Invitation to participate in Reverse Buyer-Seller Meet (RBSM) at Apparel House, Sector -44, Gurugram 10 -11 February, 2023

Dear Member,

We are glad to inform you that **Apparel Export Promotion Council (AEPC)** will be Organising **Reverse Buyer-Seller Meet (RBSM) at Apparel House, Sector -44, Gurugram, Haryana from 10 -11 February, 2023** under MAI Scheme of Government of India

In this regard, Council is inviting Authentic Buyers from Japan during the RBSM.

About Japan:

Apparel imports into Japan have been stable in the last 3 years despite of Covid 19. Japan's total imports from world was 23834.59 USD mn. in 2021. India's total export of RMG to Japan has been increasing in the last five years. India's total share of export to Japan was 1.04% in 2017 which increased to 1.22% in 2021. At a category level, Woven garments hold a much better acceptance in Japan as compared to Knitted garments. India's position at 8 in HS62 and at 13 in HS61 respectively. Tariff advantages against competing countries like China and Turkey where tariff is 9.5 in both countries whereas India's tariff is nil in HS 61. In HS 62 India's tariff is nil whereas China tariff is 9. The Main items of export to Japan are Jerseys, pullovers, cardigans, waistcoats, T-shirts, singlets and other vests of cotton, knitted or crocheted, Men's or boys' trousers, bib and brace overalls, breeches and shorts, Men's or boys' anoraks, windcheaters, wind jackets, Women's or girls' anoraks, windcheaters, blouses, shirts and shirt-blouses Men's or boys' tracksuits, Women's or girls' overcoats, raincoats & Accessories etc.,

We are expecting participation of minimum 60 Japanese buyers for the Reverse BSM at Apparel House, Gurugram. Consequent upon the travel restrictions and regulations in many countries, including India, we are getting good response from many major buyers and buying groups for their visit to the Show. This would be an ideal platform for the Indian exporters and suppliers of Readymade Garments & Accessories products to meet their customers in India, without traveling/stay to abroad.

Council's is Organising RBSM, Gurugram with 75 booths/stall and participation will be confirmed on the basis of receipt of Participation fee along with the duly filled in application form (attached). Booth will be allotted on 'first come first served' basis. Interested Exhibitors may apply immediately.

 - vi. One light socket
 - vii. Carpet flooring

The items will be increased proportionately for bigger stalls.

Extra power other than six spot lights and light socket, if any, will be charged extra. Hire charges for extra lights/fixtures/furniture will be payable by the exhibitor to the official stall contractor.

- Only One plug point socket would be provided in the bare space stall.
